ST MARY'S: OUR GOAL AND OUR NEEDS



1. Our Goal. We truly believe that St Mary's has to be at the centre of our community, to give us an opportunity to encourage and enhance both spiritual and cultural local activities. As well as helping people in any form of need, we want to engage in all aspects of community life, to bring local people and the church together at lots of different levels. That's why our stated mission is 'to be a bridge between God and our community, sharing the Love of Jesus and growing in worship, welcome and witness'.

To achieve this, though, we need your ongoing support – both financial and personal. This leaflet is about how you can help support us financially.

- **2.** Why should we give money to the Church? Our giving of both money and time supports this mission both in Sevenoaks and further afield. We give to the Church because we see God's abundant generosity in the world around us.
- **3. Our average 2023 monthly budget.** Every church large or small has to fund itself. So how much do we bring in, and what do we spend it on each month?

Our budgeted shortfall for 2023, of some £883 per month on average, is almost exactly the same as the expected increase in our gas and utility bills.

Our giving to external charities, £1,167 in the table above, is based on 10% of our regular income. Because of the budget shortfall the PCC is reviewing this policy, and expects to come to a conclusion later in the year.

4. How much money should we give? We live in worrying times. Hard on the heels of the Covid pandemic comes an energy crisis and inflation at levels not seen for many years. Some of us are really struggling to pay the bills already.

However, the New Testament teaches us to be as generous as we can in giving to God across the spectrum of the local church and other charitable causes. Not everyone, of course, can afford to increase their giving, especially at the moment. So, we simply ask you please to consider prayerfully how much you are able to provide to St Mary's.

5. What about the money we pay to the Diocese? The 'Common Fund', into which we pay each month, pays for our clergy, their housing and ongoing training and development. It pays for the training and development of our future clergy and to further the work of the Church in every parish across the Diocese of Rochester. This includes the costs of safeguarding, legal structures, communications and financial governance.

The Diocese is a wonderfully diverse and vibrant community of faith, with each parish facing different challenges and needs. Our Diocesan vision expresses our ambition to meet these challenges as a family of faith, supporting one another as we seek to grow disciples, enrich communities, and resource our mission and ministry. The Common Fund helps us realise this ambition.

6. Thank you - for all you already do to support your Church and the wider community through it, and thank you in advance if you are able to respond to this appeal and help St Mary's work even better.



Our target is to meet all our regular outgoings from regular income (i.e. planned giving plus lettings of the Church Centre). Then, when we receive the generous one-off donations which do sometimes come our way, we could use them for a specific, identified activity rather than have them bridge our funding gap. So:

- If you are already a regular giver and we are truly grateful for the financial sacrifice you make – would you please consider increasing your donation?
- If you are not already a regular giver, now is the time to consider whether you are able to help.

Whether you pay income tax or not, we can reclaim £1 in every £4 of almost all regular, planned giving through Gift Aid – but there are different ways of doing it.

- **7. How you can plan your giving.** Many of our church family give a set amount to the church, either by standing order each week, month, quarter or year, or by using dated weekly envelopes for cash. Planned giving helps us with our financial planning and budgeting, so that we have a much better idea of how much the church will have and how we can support our vision and means that you still contribute even if you can't attend church on a particular week!
- If you are a taxpayer, the best way is to set up a standing order through your bank. The bank method is easier for you (as you don't have to find cash to put in an envelope every week) and much better for us because the payment is made regularly and automatically! If your circumstances change, you can of course cancel your standing order at any time.
- If you do not pay income tax, there is the alternative of using weekly coloured envelopes. The envelopes have each Sunday's date on them, to help you remember to catch up on your pledged contribution when you are away. - **8.** What we give. Our gifts are between us and God. It is not for the church to tell you what you should be giving. However we ask you to pray, think and decide what is right for you to give to the church, alongside your other charitable donations.
